It will invest generally in companies with a market cap of between \$100 million and \$3 billion, and aim to deliver long term capital growth and out performance of the MSCI World Small Cap Index over a rolling three-year period. It's planned that the Fund will hold between 70 - 90 stocks.

Commenting on the occasion, Inside Executive Director of Product Management at Weybridge Assets Mr. Sheldon said “Weybridge Assets has a market-leading small cap capability, and launching of the Global Smaller Cap Equity Fund will be strong addition to existing small cap range of funds, with IPO activity in the small cap sector intensifying, the Fund will provide simple and cost-effective access to what we believe to be the very best smaller Companies drawn from across the world’s biggest developed markets.”
